On February 18, 2015, Coast Guard Headquarters, Office of Information Management (CG-611) received your Freedom of Information Act (FOIA) request by e-mail, requesting access to and copies of all meeting minutes and other records pertaining to any "Facility Security Committee (FSC)" for several facilities, to include "U.S. Coast Guard Training Center, 599 Tomales Road, Petaluma, CA." After an initial review, your request was forwarded from CG-611 to this office for processing and response for that portion of your request relating to "U.S. Coast Guard Training Center, 599 Tomales Road, Petaluma, CA." This letter is the final response to your February 18, 2015, FOIA request relating to "U.S. Coast Guard Training Center, 599 Tomales Road, Petaluma, CA."

I understand that my Staff Judge Advocate, CDR Sean Fahey, called you on May 13, 2015, and notified you that we conducted a comprehensive search of files within United States Coast Guard Training Center Petaluma for records that would be responsive to your request. Each individual Division comprising Training Center Petaluma conducted a search for records. As explained to you by CDR Fahey, unfortunately, we were unable to locate or identify any responsive records.

While an adequate search was conducted, you have the right to appeal this determination that no records exist within United States Coast Guard Training Center Petaluma that would be responsive to your request. Should you wish to do so, you must send your appeal and a copy of this letter, within 60 days of the date of this letter, to:
